## Specific Use Cases of DeepJudge at LEXR

LEXR's use of DeepJudge addresses several key needs that have enhanced the firm's practice and client experience.

### 1. Searching for and Summarizing Prior Advice Given on a Topic

Many of LEXR's startup clients go through similar growth stages, often requiring advice on similar topics. It's efficient to start with a common memorandum and then tailor it to the client's specific needs.

For instance, LEXR lawyers often prepare memos on the impact of complex topics such as financial regulations or data protection and digital regulations. With DeepJudge, lawyers can quickly find past memos on similar topics and efficiently assess whether a given solution or advice is appropriate for a particular client.

DeepJudge not only retrieves these documents but also

provides summarized versions through its generative AI Assistant, tailored to the lawyer's immediate needs. This enables LEXR to efficiently reuse relevant advice, quickly adapting it to the unique needs of each client without starting from scratch.

## 2. Finding the Right Template for a Client's Situation

LEXR frequently creates documents such as website terms of service or privacy policies. Although these documents are necessary and important, due to their routine nature, clients expect them to be done on a strict budget. However, the firm can't just use a one-size-fits-all template, because every client is indeed different: the contract or policy needs to be tailored to the jurisdiction of the client, its customers and the type of data (for example, whether the company will handle email addresses only, or also sensitive personal information like dates of birth, or health information). Tailoring the document each time does not make sense—few clients want to pay for a completely bespoke version.

This is another way DeepJudge Knowledge Search offers significant value. When a client needs customized terms of service, such as those complying with GDPR, DeepJudge allows lawyers to quickly locate relevant templates from past work that meet specific and nuanced criteria. Its search capabilities help narrow down templates that already address similar GDPR requirements, minimizing the need for extensive edits and saving valuable time.

LEXR leverages this capability for a wide range of contract types startup clients need – from license agreements to employment agreements.

With DeepJudge, LEXR is much more adaptable to clients' budget constraints. Instead of "recreating the wheel," each time they need to draft a contract LEXR can impress clients with on-point documentation, sourced from the best examples of its prior work product in a timely and budget-friendly manner.

## 3. Fallback clauses to help clients resolve specific issues in negotiation

LEXR often helps clients negotiate contracts with their suppliers and customers. Inevitably, the negotiation leads to the need to find reasonable compromise clauses when the counterparty objects to something in the client's template agreement. Or, if the counterparty's template is used, sometimes LEXR will need to propose suitable language that is acceptable to the client.

In both cases, DeepJudge Knowledge Search is invaluable. For example, in the software industry, negotiations around limitation of liability clauses in software license agreements are common. With DeepJudge, LEXR lawyers are able to quickly search for limitations of liability clauses across all their prior SaaS agreements in order to find the right formulation for the situation at hand.
